VIRGINIA STATE LIBRARY

RESOURCES

The Virginia State Library has comprehensive collections of printed and manuscript material that are of great value to the genealogical investigator. The printed material may be consulted in the General Library Reading Room at the east end of the building and the manuscript material in the Archives Reading Room at the west end.

PRINTED SOURCES

It would be helpful for the searcher to have some knowledge of the state's history and development. The following volumes will provide such a background, and will aid in determining the geographical areas of the state in which one's ancestors might have left some record.

Hiden, Martha W. "How Justice Grew; Virginia Counties; An Abstract of Their Formation."

"A Hornbook of Virginia History" (Rev. ed.).

Robinson, Morgan P. "Virginia Counties: Those Resulting from Virginia Legislation."

When it has been determined which county or area is to be investigated, printed abstracts of court records and local histories should be consulted. Cards for these are filed in the Catalog under the name of the locality or under such headings as "Marriage licenses; Registers of births, etc.;" and "Wills," subdivided by the name of the locality.

There are three guides to Virginia genealogies which should be consulted:

The General Library also has numerous general bibliographies and indexes of family genealogies.

Cards for compiled genealogies of individual families are filed in the Catalog under surname following the author entries. For example, following the cards for authors with the surname of Carter, the cards for genealogies of that family are found with the heading "Carter family" typewritten in red.

MANUSCRIPT SOURCES

As the repository of the state's historically valuable records, the Archives Branch of the Virginia State

Library has in its collection numerous record groups which contain genealogical source material. Among its holdings are records of the state government, copies of extant county court records such as wills, deeds, orders, and marriage bonds up to 1865, a small number of church records, some personal papers, unpublished genealogical notes, and Bible records. Available indexes are arranged by county. Because there is no comprehensive index, it is necessary that one know the county of a family's residence before initiating research in these records.

STATE RECORDS

The official nature of most state records normally precludes their being useful for genealogical research, but some do contain information of a genealogical nature. Principal among these are the following:

Tax Records.

While Virginia was a colony, special taxation laws were passed to raise revenues as needed; hence, tax records in our collection begin in 1782 when the state established a source of permanent revenue by requiring the annual collection of taxes on land and certain personal property. Lists of the returns entered by the county commissioners are available by locality for most years from 1782. Normally, only the name of the person charged with paying the tax is recorded on the list.

Military Records.

The Archives has manuscript or photographic copies of documents attesting to the military service of Virginians during the colonial period (mainly the French and Indian War), the Revolutionary War, the War of 1812, the War with Mexico, and the Civil War. Military records of Virginians who served in the armed forces after 1865 may be obtained • from the Department of Military Af-

fairs, State Adjutant General, Ninth Street Office Building, Richmond 23219; the National Archives and Records Service, Eighth Street and Pennsylvania Avenue, N.W., Washing-, ton, D.C. 20408; or the National Personnel Records Center (Military), 9700 Page Blvd., St. Louis, MO 63132. Most records of military service contain only the name of the individual and the unit in which he served; rarely do they contain either genealogical or biographical information.

Colonial service. Very few muster rolls of colonial militia units prior to 1754 are extant. Most of those which have survived are printed in such secondary sources as William A. Crozier, ed. "Virginia Colonial Militia, 1651-1776," local county histories, and various volumes of the "Virginia Magazine of History and Biography," which are indexed through 1930 in E. G. Swem. "Virginia Historical Index."

Some of the muster rolls of units which participated in the French and Indian War, 1754-1763, and Dunmore's War, 1774, have survived. Most notable among these are the militia muster rolls in the Washington Manuscripts, Library of Congress, photocopies of which are available here. In addition, volumes 7 and 8 of W. W. Hening's "Statutes at Large" contain individual references to the names of many noncombatants and to commanding officers of militia units, but not to the members thereof.

Affidavits regarding French and Indian War military service presented before a county court, accepted, and thereafter returned to the Land Office, entitled a man to a bounty of land which could be taken up within Virginia, usually in the Western and southwestern area of the state. These abstracts of court orders are Land Office records and not primary military records, but they are satisfactory proof of service.

The most comprehensive index to the sources noted above is H. J. Eckenrode. "List of Colonial Soldiers of Virginia." Not used in this compilation, however, were the county court order books and the executive journals of the colonial council. A thorough search of these sources will occasionally reveal the

commissioning of an officer; neither however, contains lists of company members.

Revolutionary War. The types of records used to establish Revolutionary War military service for Virginians who fought with either a state or Continental line unit include account books, muster rolls (the originals of which are in the National Archives) and affidavits testifying to a person's service. These sources are available here in original and photocopy form and are indexed in H. J. Eckenrode, "List of the Revolutionary Soldiers of Virginia, and John H. Gwathmey. "Historical Register of Virginians in the Revolution, 1775-1783."

In addition, Land Office, state pension, and public service claim records on deposit contain information on Revolutionary service. Only those men who served for three or more years in a state or Continental line unit and heirs of men who died in service were entitled to bounty land. The amount of land was dependent upon the individual's rank and length of service. Lands awarded for such service were located in the Virginia Military Districts of Kentucky and Ohio. Virginia kept no record of bounty land grants after issuing the warrant which entitled the individual to the grant. The number of a warrant issued to a specific individual can be established through an unpublished index to the Land Office military certificates available in the Archives.

To determine the disposition made of a particular warrant, it is necessary to write to the Secretary of State, Commonwealth of Kentucky, New State Capitol, Frankfort, Kentuckey 40601 (Attention: Land Office), or the Ohio Historical Society, Archives and Manuscript Division, 1-17 and Eleventh Avenue, Columbus, Ohio 43211.

Virginia did not pass a general pension act applying to veterans of the Revolutionary War. Each individual case was brought before the legislature for action. Approximately six hundred acts for the relief of

specific persons were passed by the legislature and are available in the Acts.

To keep the American Troops supplied, it was necessary to obtain goods and services from residents. Citations to these non-military public service claims can be located through an unpublished card index available for use in the Archives.

War of 1812. Copies of muster and payrolls from the War of 1812, totaling twenty-six volumes, are in the Archives collection. However, proof of an individual's military service during the War of 1812 is based on two printed volumes, "Pay Rolls of the Virginia Militia Entitled to Land Bounty under the Act of Congress of September 28, 1850," Richmond, 1851; and "Muster Rolls of the Virginia Militia in the War of 1812, being a Supplement to the Pay Rolls." Richmond, 1852. Both were compiled by the state from the official state records.

Mexican War. The second volume in the preceding paragraph also included rosters of the Mexican War units, although the original muster rolls are not in our collection. Only the name of the company in which the individual served and the length of his service are given in these sources.

Civil War. At the close of the war of 1865, most Confederate War Department records were confiscated by the Federal armies. Those records pertaining to service in Confederate military units were abstracted by the War Department and are available at the National Archives. The library has a microfilm copy of the records of the Virginia Confederate and Union military organizations. A typed abstract of information relevant to an individual's service can be supplied, but photocopies of actual service records must be ordered from the National Archives.

In 1888, the Virginia General Assembly passed the first of several acts providing pensions to Confederate veterans. This initial act included only those soldiers, sailors, and marines disabled in action and the widows of those killed in action. Subsequent acts broadened the coverage to include all veterans, widows,

daughters, and sisters. The applications for pensions, which contain limited personal information, are available in the Archives.

Land Office Records.

The records of the Virginia Land Office are in the collection. Of the Land Office records, the most frequently used in genealogical research are the recorded copies of land patents and grants. A patent is that document by which the Crown gave or sold the waste or unclaimed lands. A grant is the same instrument issued by the state. To obtain land, a person first paid money into the Treasury and was given a warrant (called a right or certificate under the Crown). The land desired was then surveyed, and all papers were returned to the Land Office, where the claim was examined and recorded. It was then sent to the governor to be signed. Until the final document was signed, either the warrant or survey could be transferred or assigned to another party. After it was signed, the land involved could be transferred only through action in a county court.

Patents and grants contained the same information: the name of the person receiving the land, the county in which located, the size of the tract and description of it, and the date of issuance. The survey contains the land description, and the warrant gives the person's name and the date of issuance along with the amount of land to which he was entitled.

The library does not have a comprehensive index to these Land Office records. To undertake a search for a specific patent or grant, it is necessary to have the complete name of the patentee or grantee, the county in which the land was located, and the approximate date of the document. It is important to note that neither warrants nor surveys for the patents issued by the Crown are extant, and only if an individual received a grant will a survey be recorded under his name. Further, warrants, which were recorded after October, 1779, are arranged numerically and cannot be searched by name of a particular person because they are not indexed.

The area between the Rappahannock and Potomac rivers, extending westward to their headsprings, known as the Northern Neck, was a proprietary from 1649 until it reverted to the state in 1781. After 1690, grants in the Northern Neck were entered in a separate series of volumes, for which there is an index.

Warrants issued on the basis of satisfactory military service during the French and Indian War and the Revolutionary War and certificates issued to early settlers in the far western areas of the state complete the major series within the Land Office records. Indexes naming those persons who were entitled to such lands are available, but the library does not have records pertaining to the taking up of Revolutionary bounty lands.

Vital Statistics.

Early official records of births and deaths in Virginia are almost nonexistent, as the recording was not required by law.

Few marriage records prior to 1730 survive either in parish registers or county court record books, even though such records were required by law as early as 1660/61. Marriage records in the collection date from approximately 1730. As a rule these records list only the names of the participants, the name of the security, and the date issued. Information such as the names of the parents, the ages of the couple, or the exact date of the marriage is seldom found on the document.

By an act passed in 1853, the state required the recording of vital statistics. Records from that date of 1896 and from 1912 to the present are available for a standard fee from the Bureau of Vital Statistics, 109 Governor Street, Richmond, Virginia 23219.

COUNTY RECORDS

Microfilm copies of extant court records from the date of county formation up to 1865 are available for research in the Archives Reading Room. These records generally include wills, deeds,

(minutes), and marriage bonds. For some localities there are also guardian account books or survey books, or both. Most of these volumes contain individual indexes, which are frequently incomplete. General indexes are sometimes available for wills and deeds, but there are few for other series.

Early court records of a number of Virginia counties have been lost through fire or other disaster. The greatest losses were suffered by Appomattox, Buckingham, Caroline, Charles City, Dinwiddie, Elizabeth City, Fairfax, Gloucester, Hanover, Henrico, James City, King and Queen, King William, Mathews, Nansemond, New Kent, Nottoway, Northumberland, Prince George, Prince William, Rockingham, Stafford, and Warwick.

CHURCH RECORDS

Most of the church records in the collection are administrative in nature and contain very few references to births, deaths, or marriages. The library has records of the Baptist, Episcopal, Lutheran and German Reformed, Methodist, and Presbyterian denominations dating from the colonial period to approximately 1865. However, there is no master index to these records, and individual volumes are usually not indexed. Records of a small number of churches have been published with indexes and should be consulted when available.

As the established church in Virginia until 1786, the Episcopal Church was charged by law with keeping a record of births, deaths, and marriages within each parish. Comparatively few of these registers are extant. The parish was also required to keep minutes of its vestry meetings. These volumes are solely a record of the administrative affairs of the church and do not contain genealogical information.

Other denominations were not required by law to record births, deaths, or marriages; therefore, the types of records and the information recorded therein vary widely from

church to church. Although some churches did record vital statistics, most kept only records of business meetings and financial affairs.

RECORDS OF AREAS ONCE PART OF VIRGINIA

Local court records, such as deeds, wills, and marriage bonds, were maintained by local officials at each county seat. When the states of Kentucky and West Virginia were established in 1792 and 1863, respectively, these local records were retained in the counties. However, the library does have certain Virginia state records pertaining to these areas. These include personal property tax books, land grants, and legislative petitions for the various counties prior to the dates of separation. For other state and local records pertaining to Kentucky and West Virginia, correspondence must be initiated with either the County Clerk or the state archival agency.

INFORMATION BY MAIL

The library staff cannot undertake extensive genealogical research by mail. If a personal visit to the library is not possible, a genealogist may be employed. A list of genealogists acquainted with our facilities will be furnished upon request; however, we emphasize that the list is provided only as a service and does not constitute an endorsement. The individuals listed establish their own rates and work independently of the Virginia State Library staff. Any agreement entered into is a personal contract between two private parties and does not include the Virginia State Library.

The library has facilities for supplying photocopies of documents in its collections. One should not send money when writing for information. Upon receipt of a request containing a specific reference, a member of the staff will cite relevant documents and advise by return mail the procedure to follow. As the library does supply photocopies, typed transcripts of hard-to-read documents will not be made.

Fountain Considered Result of Miracle Following Soldier's Prayers

(By Associated Press)

ATLANTA, Ga., Nov. 25

Georgia and the Southland are recovering from a drouth of unprecedented severity during which many streams and water sources dried up and all records for aridity were broken, but through it all, a cold stream of pure water continued to flow from the side of a beautifully foliaged hill on which, some 60 years ago, was located the Andersonville military prison, of the Southern Confederate army.

This is "Providence Spring," in Sumter County. Local history has it that in the closing days of the war between the states that section suffered from the effects of a drought which dried up all small streams and wells, leaving no water supply for the many thousands of Federal prisoners of war confined within the

over-crowded and fever-stricken camp.

Quinine had been made contraband of war and none was available to relieve the burning fevers which created an insatiable thirst for water.

These conditions existed for days while the men, in their delirium, madly scratched holes in the ground with their bare hands in their attempt to strike water. Finally, after having reached the end of their resources and too weary and exhausted to put forth more physical effort, they dropped to their knees and prayed to God to send them relief.

While they were still praying, a bolt of lightning struck the hill-side, just outside the "dead line," and a fountain of sparkling, cold water gushed forth to cool the parched tongues whose prayers had been heard.

Today one may visit the prison camp and find the holes marked off and enclosed within iron fences, and the staked off "dead line" which was extended to bring the spring within its confines, bearing evidence to the miracle that was performed there in the sixties. The fountain has been housed in an ornate work of masonry, in which is inserted a bronze tablet identifying it as "Providence Spring" and relating the above story.

Adjoining the camp is Anderson-ville National Cemetery, covering an area of 120 acres and where rest in eternal peace nearly 14,000 of the boys-in-blue who succumbed to the ravages of the fever and other diseases. Virtually all of the names on the plain stone slabs are preceded by the word "Private," with here and there one marked "unknown."

TRICENTENNIAL OF THE POTTENGER FAMILY IN AMERICA

The POTTENGER family began in America with John POTTENGER, who arrived in Maryland in 1680 aboard the Maryland Merchant from Sittingbourne, County of Kent, England.

He became a large landowner, portions of which acreage are today located in the City of Washington, D.C. His home place was called "Major's Lot." His wife was Mary BEALL from Scotland. They had nine children including four sons and five daughters.

All POTTENGERS in America are probably descendents of Robert POTTENGER, b. 1694, m. Anne EVANS, or Samuel POTTENGER, b. 1693, m. Elizabeth TYLER, daughter of Col. Robert TYLER, and granddaughter of Mareen DUVALL of "Middle Plantation."

Daughters Sarah m. Richard ISAAC, Mary m. William HOLMES, Rachel m. Richard PURNELL, and Verlinda m. Zephaniah WADE.

The line of son Samuel would account for most of today's family members in America through his only two sons, "Old Sam," b. 1718, and Robert b. 1728.

Some time after the Revolution (100 years after John POTTENGER first settled upon these shores), the family left Maryland at different intervals and by different routes. "Old Sam" and his entire family settled in Western Pennsylvania for a number of years.

The family of Robert POTTENGER, under the leadership of the eldest son, Captain Samuel POTTENGER of Kentucky fame, settled in Nelson County migrating through the Cumberland Gap. Later they were joined by "Old Sam" and his family, who came down the Ohio River on a flatboat to the falls at Louisville.

Captain Samuel POTTENGER, nephew of "Old Sam," was famed for his participation in the Indian Wars. Dennis POTTENGER, brother to Captain Samuel and also a nephew of "Old Sam," fought with General Anthony Wayne in Ohio.

"Old Sam" POTTENGER was about 84 years old when he migrated to Ohio with his two sons, Samuel and Thomas and three nephews, John, Robert, and Dennis. The GRAFFTS, WITHROWS, and SWEARINGENS migrated there also.

"Old Sam" was 102 years old when he died in 1820 and his wife, Eleanor (WILLETT) POTTENGER, was 96 when she died in 1822. Their son Samuel, brother to Thomas, was responsible for establishing New Baltimore in Hamilton County, Ohio.

Dr. Wilson POTTENGER and his wife, Mary Charlotte (ARMSTRONG) POTTENGER, and family moved to Manteno, Illinois in 1856 and approximately a year later removed to Kankakee, Illinois where he practiced medicine until his retirement.

James, Will, Avery, Lloyd, Marshall, and John POTTENGER were all well known around Kankakee County for many years as well drillers and nurserymen. Each, at various times, owned and operated the POTTENGER NURSERY, later known as the Kankakee Nursery.

The Tricentennial, in commemoration of John POTTENGER, was held at Bardstown, Kentucky, Sunday, October 12, 1980.

BATTLE ABBEY, The Roll of. Comp. by John B. Burke. 127 pp., indexed. (1848), repr. Balto., 1978. \$7.50

The Roll is a list of several hundred of the noble companions of William the Conqueror, and it is the earliest record of the Normans. Burke annotated the work extensively, and there are biographical and genealogical details for each name on the Roll.

BURKE'S COMMONERS. A Genealogical and Heraldic History of the Commoners of Great Britain and Ireland. By John Burke. With the "Index to Pedigrees in Burke's Commoners" by George Ormerod. 4 vols. 3,113 pp. in all, illus. (1834-1838, 1907). repr. Balto., 1977 \$85.00

This is the basic genealogical guide to families in Great Britain and Ireland who had territorial possessor official rank, but were uninvested with heritable honors. Many of the families had held land since the time of the Norman Conquest, and the genealogical coverage, which is comprehensive, extends into the early 19th century. For each family there also is an illustration of the arms with concise description. In all, there are about 2,000 pedigrees with a total of over 50,000 names. The Ormerod pedigree index supplements the name index in each of the volumes.

PASSENGERS TO AMERICA. A Consolidation of Ship Passenger Lists...
Ed. by Michael Tepper. 554 pp., indexed. (1847-1961), repr.
Balto., 1978 \$17.50

These ship passenger lists originally appeared in "The New England Historical and Genealogical Register" from 1847 to 1961. They have been excerpted in entirety, consolidated and indexed by passenger and ship. Most of the immigrants were of British or Irish provenance, and they sailed from London, Liverpool or Bristol, and landed in New York or Boston. About 18,000 persons are named in these lists.

Published source records on Washington are few in number, and this work is of unusual genealogical and historical interest, relating as it does, also to Maryland and Virginia.

- 4. That when I have finished viewing any public record or library book, I will return it to the proper or designated place.
