Genealogical Terms

LINEAL means ascending or descending in a direct line: COLLATERAL means descended from the same ancestor but not in a direct line of descent. ALLIED families are families which are usually related through marriage. An ANCESTRY begins with a single individual and traces back in time to include the male and female line of that person's ancestors. Empty Graves

When the word cenotaph is engraved on a tombstone, it means that the grave is empty. The stone was created in memory or in honor of a person buried somewhere else, such as at sea or perhaps in an unknown grave in a battlefield. LaSalle Co. GS, Jan/Feb 1993.

The recently discovered Germanic Emigrants Register is a new source for German research and may be of great assistance to find unknown German places where their ancestors resided. IGI Hint

Researchers should not overlook the "Country Unknown" section of the 1992 edition of the International Genealogical Index. This section includes 738,097 entries on 54 microfiche. Most of the names in this section come from Latter-Day Saint (Mormon) research compiled before 1970, some as early as 1844.

The entries in this section have place names that the computer did not recognize. Entries usually end up in this section because the place name was not In the correct order, had a misplaced place, or included an unusual abbreviation. Researchers can recognize about 85 percent of the places in this section. For example: pr., eastprussia, bieberstein or howden, York, eng. The "Country Unknown" section contains many names missing from other parts of the index. Since most names in this section were submitted long ago, they may contain information that has since been lost.

People in the "Country Unknown" section can be from any part of the world. About 26 percent are from Germany, 23 percent from the U.S., and 19 percent from the British Isles. Only about 15 percent of the places cannot be identified without more information. Such places, for example, may not list a country.

Before searching the "Country Unknown" section, first search the microfiche for the country where the person was born or married. If you do not find the name, try the general section for that country, for example, United States "State Unknown". Then try the "Country Unknown" section.

In future editions of the International Genealogical Index, most of these entries will be included in the proper sections. Fox Valley G.S. Vol. 10 #2, March/April 1994.

DEVEROUX/DEVERAUX/DEVEREAUX FAMILY

The Devereaux Family arrived in Illinois in the mid-nineteenth century. The immigrating ancestor was Martin, his wife Ellen and their first four children born in Quebec. Martin was born in Ireland circa 1810-13 with the last name of DEVERY and was raised in the Clonmacnoise area of Kings Co. (now Offaly). He left Ireland circa 1836-38 settling in Henryville, Quebec, Canada. He married Ellen in Henryville on 16 Apr 1839. Their first child Catherine (married O'Beirn) was born 9 Oct 1840. Their second child Charles was born 23 Feb 1843. Their third child Mary (married Bell) was born about 1845/46. Their fourth child Patrick was born 16 Mar 1848. All the records are in the St. Georges Catholic Church registers, Henryville, Quebec, Canada, or in the Montreal National Archives. The surname was changed and Frenchenized upon arriving In Illinois.

Martin's father was Thomas and his mother was Margaret S. Ellen's father was William and her mother was Catherine Ryan. In the Quebec Church records, they spelled Martin's surname as Dewoy, Dewry, Davery, Davey, Daveries, etc. They made Ellen into Helene and spelled her last name McCollifs and McCullift. These numerous surnames were written In the Church Registers for the same married couple in the one and only church (St. Georges in Henryville) that they attended for ten years. (You would think they would stick to just one misspelling!) All the problems with their surnames seems to be due to almost universal illiteracy at the time (first half 19th century); therefore, however an educated, noble or religious person wanted to spell it, that is how it was spelled.

I heard from another researcher that he thinks Ellen's parents were from Queens Co., Ireland. I believe in Ireland their surname was either McCaulift, McAuliffe) or McCowliff. But in Canada, I think it evolved to McCulloch and possibly McCullough.

The June Meeting last year was held at the Kankakee Historical Society. Helen King, the speaker, gave a wonderful presentation on the information and records available at the Historical Society. The program was video taped for the collection.

1879 KANKAKEE COUNTY DEATHS

Taken from the Kankakee Gazette

(June 19) In Lincoln township, Newton County, IN, about 5 o'clock in the afternoon of Monday, June 9th, after four days illness, Harriet, wife of Bent. W. Slater, aged 42 years.

(June 19) In Essex, William Lacy died a few days ago. The disease was consumption of the throat. His remains were interred in the Wilmington cemetery. He was of the Catholic faith.

(June 26) In Waldron, on the 16th, suddenly of apopolexy, Hamilton Perry, aged 56 years. He was born in Madison County, NY, and moved to Wisconsin in 1856. From thence to this State in 1861, where he has since resided. He leaves a wife and three children, the youngest in his 16th year.

(June 26) In Kankakee, Thursday evening, June 19, Howard W. Decker, son of W.S. and Kate M. Decker, of Denver, Colorado, formerly of this since, aged 6 years and 10 months.

(June 26) The death of the son of Judge W. S. Decker in this city, last Thursday night, was attended by unusually sad circumstances. Mrs. Decker has left her home in Denver, Colorado, three weeks previously, with the deceased son and her eldest daughter, with a view to spending the summer with her parents and friends in New York, the immediately purpose being to attend the golden wedding of her aged parents. Soon after her arrival here at the hone of her husband's parents, the child was attacked with a sickness which resulted in congestion of the brain. When it had become evident that a dangerous condition had set in, the father was telegraphed for, and he arrived in season to watch at the bedside of the little sufferer and sustain the mother in the mournful services at the grave. The funeral was attended at the Presbyterian church last Saturday afternoon by a large number of sympathizing friends. The bereaved parents left here Monday afternoon with the burden of a loss none but parents can realize.

Western fever still raging and some of the Parkites are contemplating an onward move.

Alonzo Curtis started for Great Bend, Kansas, Monday to look after his interest there.

S. B. Burchard raised the frame of a new barn this week.

Wm. Keeney has added a bay window and other extensive improvements to his residence.

Peter Johnson is building an ell to his house.

H. Baker and Wm. Wallis have added afresh coat of paint to their houses.

Dairy interests are flagging; only 40 cts. a hundred for milk at Dexter creamery.

R. Seager, Dr. Hewett and Messrs. Lyon have been stocking up with the famous Hereford cattle. Seager and Lyon from Powell's and Dr. Hewett from H. T. Miller's fine herd at Beecher, Ill., and all are giving much attention to the breeding of fine stock.

C. C. Campbell bought two very fine cows at Lipincott's sale; also, three Holstein heifers.

A new doctor in town; registed at Dr. Van Horne's for the present.

CHEBANSE - 1879

Taken from The Kankakee Gazette July 10, 1879.

Prof. Haley, of the Watseka schools, has been engaged to teach the Chebanse school the coming year.

Mr. Reuben Havens brought to our office several stalks of corn in which a black worm about an inch long was working, eating the stalk, commencing at the top. Mr. Havens informs us that they have destroyed several acres for him during the past week.

The spiritualists had a picnic at Sugar Island last week.

LOCAL NEWS - 1879

Taken from The Kankakee Gazette, July 24, 1879.

Dave Babel wants to be baker at the asylum. He would make a good one.

Dr. Dewey, the new asylum superintendent, is expected here within a couple of weeks to look after the preliminaries for the reception of patients.

Wm. Schneider, of Peotone, who was sent to the penitentiary last winter, for two years, for destroying some buggies belonging to John Powis, was pardoned Sunday last.

Five hundred and ten children were born in Kankakee county during 1878, of whom 249 are stated to be males, 255 females and 6 are without sex - according to the way the returns of the physicians read.

The Ottawa cutlery works have been purchased by W. Bonfield, Emory Cobb, L. B. Cobb and F. Crawford, of this city. T. F. Andrews, of Chicago, and Jim Paddock, of this city, will be connected with the establishment.

Rosa Jameson, of this city, aged 20, died in the Elgin asylum last week. Funeral services were held in the Baptist Church here, after which the remains were taken to Waldron for burial. She was subject to epileptic fits, but in the intervals between the attacks she was perfectly same.

TRANSCRIBING RECORDS.

Jacob Gutterson was appointed commissioner to transcribe all deeds, mortgages and title papers relating to the title of lands lying in Kankakee county that had been recorded in the records of Wi11 county and Iroquois counties at a compensation of eight cents per 100 words.

LOCATING COUNTY SEAT.

The election to locate the county seat was duly held Tuesday, June 21, the village of Momence and Kankakee Depot being entered as contestants for the honor, and resulted in favor of Kankakee Depot, now the city of Kankakee, although no records exist of -the vote cast for either of the locations it is said to have been the most closely contested election ever held in the county. The fact that Kankakee Depot was located near the center of the county, had a railroad, a donation of \$5,-000.00 in cash towards building the court house, and .the gift of block 16 upon which the court house is situated, undoubtedly had its influence with the voters of the county.

The first meeting of the board of supervisors convened in the village of Momence, Monday, July 18, 1853. There were present the following: Russell Seager, of town of Yellowhead; Orson Beebe, of town of Momence; James Byrns, of town of Aroma; Henry S. Hall, of town of Bourbonnais; Virgil Lamb, of town of Limestone; George Gay, of town of Rockville and George M. Stowell, county clerk.

The board organized by the selection of James Byrns as chairman, by a unanimous vote. The first business transacted by the board was to direct the county clerk to procure from the proprietors of the town site, Messrs. Ketchum ^sand Gray, trustees, a bond for the sum of \$5,000.00 towards the construction of a court house, and a deed for the present court house square, and have the deed placed on record.

On motion of Supervisor Orson Beebe, Uri Osgood, attorney, residing at Joliet, was allowed a fee of \$100.00 for services rendered in the organization of the county, for taking returns of election to Springfield, appearing before the state officers in behalf of the new county, and procuring and returning with the commissions of the several officers. Russell Seager voting nay.

Allen Rakestraw and John Baum were each granted license to sell spirituous and vinous liquors for the space of six months, each giving bond and paying a fee of \$25.00. Russell Seager voting nay.

Sheriff George W. Byrns was directed to procure offices for the county officers and court room at or near the county seat, and when so procured to notify the respective officers. Whereupon the board adjourned to meet at the county clerk's office in Kankakee depot, on Monday, September 12, 1853.

Board convened pursuant to adjournment, in the upper part of the Illinois Central R. R. freight horse.

All present except Supervisor George Gay, of Rockville.

The first business in order was the selection of grand and petit jurors for the November term of the circuit court, and were as follows:

Yellowhead—Grand: Jacob B. Hamilton, John Bennett. Petit: George Sweet, John Hayhurst, Sr., Eatin Hicks.

Momence—Grand: Wm. S. Chatfield, Samuel B. Randall. Charles Daslriell, Oscar F. Rowley, Lyman Wooster. Petit: Henry Scratnlin, Walter B. Hess, A. B. Parrish, William Haslet, Newell Beebe.

Aroma—Grand: Augustus M. Wylie, Vincent T. Lowe, Elisha Parsons, George Cooper. Petit: Jesse Brown, Revillo Beebe, L. H. Kibbon, Benjamin True.

Limestone—Grand: Joel B. Hawkins, Roswell Nichols, Edward Daylor, James Lamb. Petit: Friend C. Bird, John Cowgill, Job Williams, John Holliday.

Bourbonnais—Grand: William Durham, John Worrell, Abram True, William Rantz, Pleasant Durham. Petit: Daniel T. Van Miter, Zohman Fuller, George V. Ruling, Harris K. Durham, Alexander Burcham.

Rockville—Grand: James _F. Merrick, Samuel Taylor, Martin P. Forbes. Petit: John Mann, Henry Van Meter, William Gap.

Sheriff Byrns reported that he had, in compliance with previous order of board of supervisors, secured the upper part of the Illinois Central freight house for county offices, and had notified the several county officers. Circuit Clerk Gutherson was authorized to procure the clerk's office on the second floor of the store of O. B. Jackson, situated on East avenue.

Bond for \$5,000.00 of Ketchum and Gray was given in favor of Philip Worcester, H. S. Bloom and Orson Beebe conditioned, to aid in the construction of a court house was presented, and by them duly assigned to the board of supervisors.

At the October meeting County Judge Philip Worcester was authorized to go to Springfield and procure such books as the county might be entitled to, and to receive as compensation for his services, \$1.50 per day and expenses. At the November meeting, a Mr. Stacey was allowed \$335.50 for records, blanks and stationary.

Grand and petit jurors were selected.

Bill of Norman Orcott for \$21.50 for making seats for jurors was presented; \$12.50 was allowed.

A. S. Vail was allowed \$3.00 for moving county records, furniture, etc., from Momence to county seat. Samuel Knight, lumber for seats for jurors \$7.04, November 1st, 1853.

The board made its first tax levy on each \$100.00 valuation as follows: State, forty-nine and one-third cents; county, twenty-five cents; Yellowhead, nine cents; Aroma, eight cents; Bourbonnais, six cents; Momence, five cents; Limestone, seven cents; Rockville, six cents. School and other special taxes. From this first tax levy there was an abatement of errors to the amount of \$424.77.

The county clerk was directed to prepare the collector's books and instruct the several town collectors to collect such tax in gold and silver.

At the general election held November 8, 1853, the following named persons were elected county officers for full term: James M. Perry, county clerk; David Perry, county treasurer; James Gay, county superintendent of schools.

Meeting of board of supervisors held November 28, 1853. Official bonds of the several county officers were presented and approved. Among other bills allowed was that of Judge Philip Worcester for services and expense in going to Springfield, in the sum of \$32.25. First term of circuit court was held in November, 1853, in the second story of the Illinois Central freight depot, Judge Henderson ,of Joliet, presiding. Attorneys present were: Thomas P. Bonfield, Ira Bartlett and Charles R. Starr, of Kankakee; Uri Osgood, W. S. Randall, Elisha Fellows of Joliet; John W. Paddock of Lockport and James Fletcher of Middleport.

It will be noted that Thomas P. Bonfield is the only person now living who, as attorney or officer, attended this, the first term, of the circuit court. All of the grand jurors have since died, anti of the petit jurors, John Mann, of Rockville, is the only survivor.

Thomas P. Bonfield came here August 11, 153. Judge Ira Bartlett came in September, and Charles R. Starr in October. The same year John W. Paddock moved his family here, occupying the stone building in lot 2, block 38, at the corner south of "Farmer's Home on East avenue.

The second and third terms of the circuit court were held May 29 and November 13, 1864, in the stone part of the Van Meter hotel, which is still standing in the 5th ward. Judge W. S. Randall of Joliet presiding.

The board authorized the rental, when completed, of the stone building of Henry S. Hall, for county offices, at \$7.00 per month, the lower story to be occupied by the county clerk, county treasurer and county judge, and the second story by the circuit clerk and sheriff. Wesley Bonfield, then a clerk in the recorder's office, and Thomas P. Bonfield, occupied a small apartment in. the rear of the building as **a** bedroom.

In the early days ft was the custom for they grocery stores to include liquors in their general stock, which usually was sold by the gallon. Customers purchasing a bill of goods were welcome to help themselves to a dram or two, from the original package, and for: this convivial purpose a license fee was fixed at \$20.00 for three months, \$35.00 for six months, and \$50.00 for twelve months. Thee county clerk was directed to issue the liquor licenses during vacation, taking bond as required by law, the transaction to be subject to the approval of the board. Russell Seager it is noted, on all occasions, public and private, used his influence against the liquor traffic,] Liquor license granted Horace Gardner and D B. Peck were revoked at the March meeting of the board upon complaint of Cyrus Ingraham.

who alleged that they kept a disorderly grocery. Thereupon the board refunded the sum of \$40.00.

COURT HOUSE.

Suitable buildings for county purposes not being obtainable in the new county seat, it was thought best to proceed at once to the erection of a court house, and, in accordance therewith, Supervisor George Gay, of Rockville, presented a resolution to build with as little delay as possible. The structure was to be of brick or stone 55 feet front, by 76 feet deep, and 35 feet to top of plate. The lower story, or basement, to be arranged for the jail and jailer's room, the second story for county offices and jury rooms, and the third, and upper story, for a court room. \$50.00 was appropriated for plans and specifications acceptable to the board. No further proceedings were had relating to the erection of the court house until March 15, 1854, when, upon motion of Supervisor Seguin, the chair appointed a committee consisting of Orson Beebe, and Virgil Lamb, to procure such plans, specifications and estimates, as, in their judgment, were advisable, and report same at an adjourned meeting, to be held on the 24th inst. The committee approved plans, specifications and estimates presented by Messrs. Otto H. Matz and W. H. Burrell, which, upon motion of Mr. Seguin, were adopted by unanimous vote.

At a meeting of the board held April 28th, on motion of Supervisor 'William C. Richard, the court house plans were amended so as to read: "The floors of three of the cells of the jail shall be laid with, flag stones not less than six inches deep, and of dimensions to require not more than two for each floor. Under all the flooring of the cells of the jail was to be rubble masonry one foot in thickness."

On motion of Supervisor Francis Seguin, of Bourbonnais, the county clerk was instructed to advertise in the Kankakee Gazette, Chicago Journal, Chicago Democrat and Joliet True Democrat, for sealed proposals to build the court house, in accordance with plans adopted, the walls and roof thereof to be completed by November 1st, following, and the entire building to be completed on or before the first day of July, 1855. Such sealed proposals were to be Sled with the county clerk the first day o! June, 1854, together with bond for the completion of the work. When the board met June 1st, it was thought expedient to change the plans somewhat, and the sealed proposals were handed back to the respective bidders. The board thereupon proceeded to make certain changes in their plans and on the following day submitted same to the bidders, who at once proceeded to revise their proposals, only two of which were presented to the board.

Robert J. Cunningham's bid was \$19,182.80 and Gent Linsley & Co's bid was \$20,800. On motion of Supervisor Seguin, the contract was awarded Robert J. Cunningham. Subsequent changes were made entailing an additional cost of \$3,294.49, making a total of \$22,377.29 for the completion of the court house.

The county committee consisted of James M. Perry, Francis Seguin, William C. Richard, James Byrns, George Gay, Alanson Hawkins and J. B. Hamilton. J. W. Fenton was appointed architect and superintendent of woodwork, and was paid \$44.00 for his services.

The building completed, the first term of the circuit court was held therein in September, 1855. It will be noted that the stone used in the construction of the court house was procured from what is known as the Lime Stone quarries, about six miles down the river, as at that time no quarries had been opened in the new town.

The rooms and cells on the lower floor were much as at present. Second floor, southwest corner, now used as supervisor's room, was occupied by the circuit clerk, and the county clerk's office was in the southeast corner, now occupied by the circuit clerk. As a vault occupied the south end of the hall at that time, there was no entrance from the south, as at present. The vault, which was small, and used by both the circuit and county clerks, was constructed entirely of wood. The third floor was finished as a court room. The board of supervisors, realizing that in case of fire the county records would be in danger, took under advisement the resolution presented by Supervisor Harrison Loring, at the meeting in April, 1867, that the chair appoint a commit tee of five to report plans and estimates for constructing a fire proof vault, either within or without the court house. The chair named

its committeemen, Messrs. Harrison Loring, Daniel G. Bean, John C. Mateer, Emory Cobb and William H. Patterson, and upon whose recommendation the second floor of the building was rearranged, with the offices and vault as at present. Daniel G. Bean was the architect and superintendent of construction, and William H. Hamilton the contractor. In taking out the vault over the hall, it was found that some of the timbers were badly charred, indicating that an undiscovered fire had extinguished itself, a most unusual but excedingly fortunate circumstance. In constructing the vault as it is at present, two cells were used for the foundation, being filled from ground to floor of vault with stone and concrete. During the re-arrangement of the second floor the county officers occupied the court room, but so expeditiously was the work carried on that they were back in their old quarters in time for the September term of the circuit court.

In October, 1872, while final orders were being entered, prior to the adjournment of the circuit court, a fire was discovered in the cupola of the court house. Being difficult to get at, and no water supply or other means of extinction being available, nothing could be done, but stand by and witness the destruction of the entire woodwork of the building. Fearing the records in the vault might be injured, it was thought prudent to remove them and the furniture from the burning building. Offices were at once secured of Frederick Swannell, in what was known as the "Earthquake Block'," at 231 and 232 Court street, now occupied by Erzinger Brothers. Immediately the county proceeded to erect a fire proof building in the rear of these offices in which to temporarily place the records.

There was an insurance of \$20,000.00 on the burned building. The board of supervisors had an estimate made by competent builders, none of whom would agree to reconstruct the building for less than from \$22,000.00 to \$24,000.00. The insurance companies endeavored to effect a settlement for \$15,000.00, but the board stood firm in requiring the full amount of insurance, or a replacing of the building. Several of the companies interested sent a Mr. Donnelly, from Chicago, to pass upon the matter, and he eventually contracted to rebuild the courthouse. It

is not known just what it cost the companies to complete the work, but the sum assuredly was not less than the full amount o! insurance. Frederick Swannell and George V. Haling were the county superintendents of construction. In the fall of 1873 the court house was again ready for occupancy. So far as offices and court room are concerned, the building might answer the purpose of the county for many years to come, although there is a pressing need for more fire proof vault room in which to place the rapidly increasing valuable records which, once burned, would be impossible to replace. Although inadequate in size, it is gratifying :o know that the present vault offers absolute safety to the records stored therein, it having been put to a severe test several years ago, when a large amount of debris, falling on and around it, burned for several days. Upon opening the vault, it was found that the paint on the inside doors was almost intact.

CHAPTER VIII.

Swamp Lands—How Counties acquired Such Lan^g—Orson Beebe First agent—Total acres 41,000, Sold for \$95,000.

By an act of congress, passed September 28, 1850 and entitled "An act to enable the State of Arkansas to construct the necessary levees and drains to reclaim the swamp anal overflowed lands therein"; "the whole of those lands made unfit thereby for cultivation, which shall remain at the passage of this act, shall be, and are hereby, granted to said state."

By subsequent act of the general government, each of the other states were granted like lands, lying within their respective borders. The act provided, that, in the selection o! such swamp lands, the same should be made by legal subdivisions, that is, each forty acres separately, providing that "should the greater part thereof be wet and unfit for cultivation, then such tract should be included," but,

"should the greater part thereof be pot wet and unfit for cultivation, then such tract should be excluded."

The state of Illinois, by act approved June 22, 1862, granted to the respective counties, all such lands lying within their respective limits the proceeds of the sale of such lands to be expended by the board of supervisors (in counties adopting township organization), in the construction of levees and drains to reclaim the, same, and if any surplus remained it was to be equally divided among the several townships of the county, for the purpose of education, building bridges or other purposes.

By an act of the legislature, approved March 4, 1864, the title to the swamp lands lying in Kankakee county was vested in the county, being made conditional upon Kankakee county refunding the expense already incurred by the counties of Will and Iroquois respectively. The auditor of public accounts was authorized to certify and patent such lands to the county of Kankakee upon the presentation of evidence of such settlement by the county agent authorized to make such settlement with the counties before mentioned.

April 27, 1864, Orson Beebe was appointed, by the board of supervisors, such agent on the part of Kankakee county, to make settlement with the counties of Will and Iroquois. This service he performed in a most satisfactory manner.

By this same act the office of "Drainage Commissioner" was created, and William C. Richards was appointed to the office, which he held continually until his death. Mr. Richards was succeeded by Nathan Chester, who held the office from the time of his appointment in September, 1876, until his death in January, 1896, since, which time the office has been vacant.

Mr. Richards, as commissioner, sold all the lands at prices fixed by the board of supervisors, the price obtained for the most of it being \$1.26 an acre; the last lands sold, however, consisting of about 16,000 acres lying almost wholly in the Town of Pembroke, brought \$3.60 an acre on four years' time with interest, with the special agreement that the county would be exempt from expending the money so derived in draining these' lands. There were sold and deeded as swamp lands about 41,000 acres, the proceeds of which were upwards of \$95,000.00.

of the money received from the sale of these lands, the supervisors from time to time appropriated various amounts among others, for the payment of bands issued for the construction of the court house; for the construction of bridges across the Kankakee river at Kankakee, Aroma and Momence, and other minor bridges throughout the county; for grading the court house square; to reimburse A. W. Mack, A. S. Perry & Co., A. S. Vail, C. R.. Starr, Bela T. Clark and James McGrew, for monies advanced by them in the survey of the Fort Wayne & Western Air Line railroad through this county; and for sundry other purposes to the amount of from \$40,000 to \$45,000.

It will be noted that while some counties sold their swamp land for a lump sum to speculators, Kankakee county sold hers mostly to actual settlers, at prices approximately their actual value as compared with adjacent land. The money expended for drainage purposes throughout the county was appropriated by the board of supervisors from time to time for contract work under the supervision of the commissioner, the contracts being awarded by public letting. The actual location of the drains was frequently made by the individual members of the board against the judgment of the commissioner.

The act of congress, granting the swamp and overflowed lands to the several states, provided that the money derived from the sale of swamp and overflowed lands be expended for the purpose of constructing levees and drains. Had the swamp land money of this county been used in the construction of main ditches throughout the county, instead of so many laterals, with indifferent outlets that filled up and became useless in a few years, much more general benefit would have been derived. However, the expenditure of this money rendered thousands of acres of wet and overflowed land productive, besides draining other land that had no claim on the county, including that inside the six mile strip on each side of the Illinois Central railroad right-of-way.

CASH INDEMNITY

The act of congress approved March 2, 1865, provided that all swamp lands sold by the general government subsequent to September 28,


